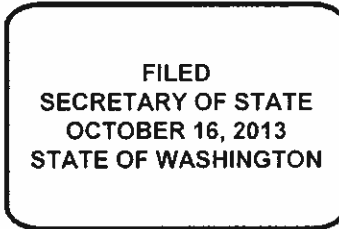

Purpose	The purpose for which the King County Incident Support Team is organized is to provide timely, quality support services to the King County Sheriff's Office and units of the King County Search and Rescue Association. To achieve this purpose, the King County Incident Support Team will provide support and expertise in incident command, planning, logistics, record keeping, and communications before, during, and after search and rescue missions, special events, and for other lawful purposes in accordance with RCW 24.03.015. The King County Incident Support Team is organized and operated exclusively for charitable, religious, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Distribution of Assets	Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
